- Implemented NIATX model for process improvement in all programs under my purview. Made process improvement part of our culture-focused on making small changes and quickly measuring results to have meaningful impact on service delivery, client care and employee satisfaction.
- Chaired agency-wide Gender Responsive Clinical Training to address gender specific treatment for all ninety programs in the agency. Women and girls certifications completed for all programs with men and boys training rolled out companywide. Emphasis on bringing research to practice.
- Improved existing intern program by creating system to update current openings and streamlined structure to better recruit, track and follow all clinical interns of agency. Served as primary contact for local educational institutions looking to place interns in agency programs.

- Created housing opportunities for individuals with mental health and substance use disorders. Included negotiation of purchase opportunities, master leases and community relations. Prepared targeted proposals to protect existing funding and secure new support. Implemented *Housing First* model to improve client access and outcomes.
