Person-Environment Interactions and Alcohol Consumption: The Role of Alcohol Outlet Density.
Role: Principal Investigator. Direct Costs: \$1,000

The use and abuse of alcohol by adolescents and young adults in the U.S. remains one of the most important public health problems of the 21st century. The identification of contextual or environmental factors that moderate the direct effects of individual level variables on alcohol use can help with the development of targeted interventions for groups of individuals who may be at greatest risk for alcohol-related problems, abuse, dependence, etc. The studies included in this project will test whether environmental factors such as alcohol outlet density interact with individual factors such as gender, race/ethnicity, personality, religiosity, and genetics to influence alcohol use behaviors (frequency of drinking, quantity of drinking, heavy episodic drinking (HED), number of days drunk) in ways that are more complex than what studies testing the direct effects of these individual and environmental factors have found. These studies utilize data from the National Longitudinal Study of Adolescent Health (Add Health).

San Diego State University, University Grants Program "The Moderating Effect of the Environment on Predictors of Alcohol Use." Role: Principal

Investigator. Direct Costs: \$9,241.

The purpose of this project is to examine the moderating effects over time of the macro environment on the genetic contributions to alcohol and tobacco use behaviors using 3 waves of data from the Add Health survey. Given the important social problems associated with these behaviors, the research described in this proposal will provide additional insight into how to better target interventions to those in the population who are most at risk of developing substance use disorders.

CURRICULUM DEVELOPMENT AND TEACHING INNOVATIONS

SW391: Created a data collection and analysis project that requires students to develop a research question and hypothesis testing some aspect of human behavior. Students also created a data collection form, collect data from participants, analyze the data, interpret the results, and write a formal research report.

SW 430: Developed a writing assignment in which students were asked students to describe a portrayal of drug use in popular culture (i.e., movies, music, T.V., books, etc.) and to assess whether research supports (or refutes) a connection between media portrayals of drug use and the use of alcohol, tobacco or other drugs among children, adolescents or young adults. Students were also required to discuss whether they believe the government (Federal, State or Local) should enact stricter policies limiting exposure to media portrayals of drug to young people in this country. This assignment required students to assess the research as well as alcohol and drug policy literature. Developed a course blog for students to share information as well as personal observations/opinions related to alcohol and other drug use.

SW 610: Developed two innovative data analysis projects/paper assignments to demonstrate how

to analyze, interpret, and write about survey data and data from a randomized controlled trial. These assignments were integrated successfully into my courses during the fall and spring semesters in the 2008-2009 academic year.

SW 619: Created a major writing assignment requiring students to apply organizational behavior theory to an experience working or volunteering for a human service agency or organization. This assignment gives students the ability to demonstrate their knowledge of theory by allowing them to describe a pertinent experience rather than merely having them describe theories in a research paper. This assignment was successfully integrated into my courses during the fall 2009 and 2010 semesters.

SW 620a: Designed a major writing assignment in which students are asked to synthesize and integrate human development theory into a description of a period of their life or the life of a close relative or friend. This assignment also promotes the application of knowledge as opposed to simply describing or analyzing a theory.

SW881: Developed a secondary analysis assignment in which students are asked to develop a research question focused on substance use and subsequent set of multivariate statistical analyses. Students then write up a manuscript suitable for publication. This assignment is designed so that students can get started on an independent research topic with the hope of publishing the results of the analyses.
