Gero 101 - Introduction to Human Aging

This is an introduction course to the field of human aging that looks at aging from multiple perspectives that include the social, political, and biological sciences, arts and humanities, care giving and social services.

Gero 250 - Intergenerational Issues and the Elderly

This course explores the controversial issues surrounding interpersonal relations between the older adults and other age groups.

Gero 370 - Images of Aging in Contemporary Society

This course explores how older adults are represented in the media. The course changes every semester/term depending on the current socio-political context.

Swork 360 - Perspectives on Human Behavior and the Social Environment

This course provides students with the practical knowledge of the ecological framework for understanding the person in the context of the environment

Swork 610 – Computer Applications in Social Work Practice

This course provides students with a practical knowledge of social work research based on a combination of a statistical computer application and the Internet technology. This course provides students with continuity and linkage in social work research learning between *Social Work 690* (Introduction to Social Work Research Methods) and Social Work 791 (Applied Social Work Practice Research Seminar).

Swork 619 - Human Behavior and the Social Environment: Groups, Organizations, and Communities
This course examines and interpret human behaviors at group, organization, and community levels.

Hums 101 - Introduction to Human Aging

This is an introduction to the field of social gerontology. A multidisciplinary approach is utilized to examine the basic biological, psychological, and social theories of aging.

Hums 110 - Social Work Fields of Services

This is an introduction to the major fields of social work practice in institutions, public and private agencies and other community settings. Students examine and differentiate between the predominant settings in which social work is practiced and the role of social work in contemporary society in relation to social injustice, diversity, cross-cultural issues, and economic factors.
