I. Early preparation to engage in dissertation research discussion with your mentor

#### 1st and 2nd year students are recommended to:

- Talk to your mentor they need to have an idea of what they want their topic to be who has expertise in that area, do they plan to pursue NIH or other funding
  - o Narrow your research topic (see following guide on dissertation planning)
  - Help with identifying other professors with expertise in your area of interest
  - Help with identifying potential committee members
  - Help with developing an F31 or R36 (or other) proposal
  - o What to do if your mentor has limited capacity to support you
  - Data
  - Identify data sources You need to know whether you might want to collect your own data or use someone
    else's, you don't have to identify a source at the early stage of dissertation planning, but you need to know
    what direction they want to go and on what kind of topic.
    - Can you use a publicly available dataset?
    - Does your mentor have data you can use?
    - Can your mentor introduce you to another professor with data you can use?
    - o Or collect your own data
    - Can you join a project that is currently running?
    - Do you need funding? (incentives for participants?)
    - Do you have access to the people from whom you want to collect data?
      - Who could help you access them?
        - Pros/cons to think about when deciding what data to use

**Committee Composition: (See eligible faculty here:** 

#### Minimum 5 members (six possible)

**UCSD 2 faculty from Department of Medicine or from list of approved persons who can serve**; in cases for faculty with specific expertise who are outside the School of Medicine, a petition for them to serve as a committee member may be made but Deanship approval is not guaranteed\*.

SDSU 2 School of Social Work or from list of faculty who have been approved by the SDSU College of Graduate Studies to serve as 'internal member' (as if they were from the School of Social Work); Co-Chair or "outside member" (from outside School of Social Work).

One faculty 'outside' person not from either department.

#### Additional guidance:

As per UCSD Graduate Education, at least 2 members differing in academic specialty from student, regardless of whether members are from inside or outside the student's department.

\*On a case-by-case basis, a student may request JDP Directorship support to seek an exception from the UCSD Graduate Division Dean in order to request inclusion of a committee member who is outside the Department of Medicine and/or who does not meet Professor Title as per UCSD guidelines (Ph.D. committee composition table: <a href="https://grad.ucsd.edu/academics/progress-to-degree/committees.html#Doctoral-Committee-Membership-T">https://grad.ucsd.edu/academics/progress-to-degree/committees.html#Doctoral-Committee-Membership-T</a>)

This may occur, for example if a student has been working with a faculty researcher with substance use research expertise from another department who may not fit the UCSD table criteria for who can serve as committee chair or member of a committee with specialized.

Deanship approval is NOT GUARANTEED, therefore students should inquire early if their mentor is suited to serve as Chair or committee member.

Provide support that indicates the need for the type of study that is being proposed.

Indicate short and longer-term implications of the proposed research

Include a brief review of the literature with relevant citations and/or outline of additional topics to be included in the review of the literature for the full proposal.

**III. Dissertation overarching research aim:** (include brief background on topic, clearly articulate the research gap and how your proposed research will contribute to filling this gap in the science)
