- ❖ Appointed as the CWS Ombudsman/Civil Rights Liaison 2001-2004
- ❖ Secretary of the SD County Child Abuse Coordinating Council, Child Fatality Committee; a collaborative convening to review and analyze child deaths occurring in San Diego County. (2001-2004)
- ❖ In 2007, selected as the first CWS Agency-Wide Drug Endangered Children (DEC) Coordinator to address the methamphetamine epidemic in SD; facilitated partnerships with DEA, DA's office and local law enforcement agencies.
- ❖ Coordinated a federal grant writing partnership between CWS, Alcohol and Drug Services and Rady's Childrens Hospital (2007); awarded \$2.5 million dollar grant for the Family Integrated Treatment (FIT) program.
- ❖ In 2008, became the county's first Department of Justice (DOJ) Grievance Hearing Officer. Established the CWS DOJ Hearing Unit and DOJ Child Abuse Central Index (CACI) Grievance process for CWS in SD County,
- ❖ Established the CWS Administrative Case Review (ACR); executive risk management case review of high-risk child abuse cases (2010).
- ❖ In 2012, pursued partnership with CA Youth Law Center and implemented the *Quality Parenting Initiative (QPI)* for SD County; a state and nationally recognized collaborative caregiver approach for child welfare agencies
- ❖ *In 2013, at the direction of the County of SD Board of Supervisors, created and launched the Exceptional Families for Exceptional Children Adoption Recruitment Campaign; increasing Adoptions in SD County.*
- ❖ In partnership with Public Health, served as the CWS Executive lead for the system improvement project leading improving medical and dental exam compliance for foster youth. This effort received national recognition (NACO)
- ❖ In 2016 - 2017, led implementation of State Mandated Resource Family Approval (RFA) program; a statewide reform to unify and streamline the caregiver approval process for CA.
- ❖ Appointed the agency's first CWS Director of Child Welfare Practice.
