Additional roles constituted counseling parents, providing support to children and parents by assisting them in locating support groups, providing in home parent education, such as conducting individual psycho educational sessions, educating the clients on a range of adoption, child development, parenting topics and other referrals as needed. Moreover, I had the opportunity to work with children who have been suffering with grief and loss issues, such as those expected, through the separation from their current placements and aiding them through the transition into their new prospective adoptive placements. Additionally, I appeared on the Adopt 8 program featuring a child in need of a “forever family.”
